ORDER

In pursuance of the Resolution No. 105 of the Affiliation Committee, D.U. in its meeting held on 14.05.2013 and under report to the Executive Council, D.U. the Hon'ble Vice-Chancellor, D.U. is pleased to grant provisional permission to the Asian Institute of Management & Technology, R.G. Baruah Road, Guwahati to start:

- (A) **B.Com. Programme in General Standard** w.e.f. the academic session 2013-14 with 01(One) Section in the following subjects, subject to fulfilment of the following conditions:

Subjects :

Business Communication, MIL(Assamese, Alt. English, Bengali, Hindi), Business Economics, Business Environment, Business Mathematics, Business Statistics and other subjects as per the syllabus of the Dibrugarh University.

Conditions :

- (1) One more teacher with the UGC norms having specialization in - Accounting & Finance shall have to be appointed before commencement of the First Semester Class.
- (2) One more teacher in Economics and one more teacher in English with the UGC norms shall have to be appointed before commencement of the Third Semester Class.
- (3) Two teachers in Statistics with the UGC norms shall have to be appointed, one before commencement of the First Semester Class and the other before commencement of the Third Semester Class.
- (4) More Text and Reference Books as per the syllabus shall have to be procured by the College before commencement of the Class.
- (5) The College shall have to appoint at least 2(Two) teachers with UGC norms in each of the subjects in MIL (Assamese, Bengali and Hindi) one before commencement of the First Semester Classes and other before commencement of the Third Semester Class.

- (B) **Speciality in (i) Accounting & Finance and (ii) Marketing** in the B. Com. Programme w.e.f. the academic session 2013-2014 subject to the fulfilment of the conditions mentioned against them.

- (1) The College shall appoint at least 2 (Two) teachers having UGC norms with Specialization in Accounting & Finance one before commencement of the Third Semester Classes and the Third before commencement of the Fifth Semester Classes.
- (2) The College shall also procure at least 100 (one hundred) Nos. of titles of Text & Reference Books and at least 2 (Two) Journals for each of the Specialities before starting the admission process.

- (3) The College shall have to arrange separate Class Rooms and Departmental Library for each of the Specialities.
- (4) The maximum intake capacity in each of the Specialities shall be 30 (Thirty).
- (C) **M.A. in Mass Communication** w.e.f. the academic session 2013-14 subject to fulfilment of the following conditions :
- (1) The College shall have to invite part-time teachers and professionals for taking classes.
- (2) The maximum intake shall be 40(forty)
- (3) More books and journals shall have to be procured as per the syllabus.
- (4) The number of Computers in the laboratory shall have to be increased for the convenience of the students before commencement of the First Semester Class.

General conditions :

- (1) The College shall have to procure land and construct its own building as per the University requirements within a short period.
- (2) The Governing Body shall have to be formed as per the University / State Govt. Rules.
- (3) A regular Principal shall have to be appointment as per the State Govt. / UGC norms.
- (4) The College shall have to appoint regular teachers as per the State Govt. / UGC norms.
- (5) The College shall to submit an undertaking to the University to comply with the above mentioned conditions and relevant University Rules before starting the admission process.
